# Declaration and Understanding of Enrolment

I am aware of the conditions of a Class 500 Study Visa and, if successful in gaining enrolment at Mercedes College and obtaining a Visa, I must:

- Meet the academic requirements of the course as outlined in point two, below
- Meet the attendance requirements of the college as outlined in point three, below
- Meet the attendance requirements and have travel schedules approved before making bookings for travel
- Maintain current Overseas Student Health Cover
- Have Mercedes College approval (based on academic achievement) to seek part-time work for 20 hours or less per week, in accordance with the Student Visa Regulations.

## Conditions of Enrolment

1. I understand that I will be tested upon starting my course and that my course may be varied according to the results of that test. I will then be placed in the appropriate classes.
2. I understand that I must complete all class work, activities, assignments, and assessments and achieve a minimum average of 50 per cent (Year 6 to Year-10) and 60 per cent (Year 11 and Year 12) to maintain satisfactory progress, and that failing to do so will mean intervention by the College.
3. I understand that I must attend at least 90 per cent of my course, and failing to do so will mean intervention by the College. Failing this requirement may lead to non-compliance of my Visa, with a warning from the Academic Advisor, followed by a subsequent report to the Department of Home Affairs (Immigration).
4. I understand that I must wear the school uniform as required by the College.
5. I understand that I must live in Homestay or independent accommodation approved by Mercedes College, until completion of studies at Mercedes College.
6. I understand that while living in a Homestay, rules will apply to the household, to be explained upon arrival. The Homestay host may offer additional verbal guidance to ensure the physical safety and wellbeing of everyone in the household, and provide support to make sensible, considerate decisions in relation to living in the household and respecting the property of the Homestay host.
7. I have read, understand and accept the guidelines outlined in the Homestay brochure including curfew times. If I do not have a copy of the brochure in my possession, I will ask my agent for a copy, or read the copy on the school website [mercedes.catholic.edu.au](http://mercedes.catholic.edu.au). I understand will also be given a copy upon arrival at the school, during orientation.

8. I understand the need to provide one Semester's notice before withdrawing from the College academic programme.
9. I understand that I cannot change my school until I have completed six months of full time study at Mercedes College. A letter of release by Mercedes College will be required.
10. I understand that my personal information may be shared with the Australian Government, and designated authorities. This information may include personal contact details, course enrolment details and changes, and circumstances of any suspected breach by the student of a student Visa condition.
11. I agree that Mercedes College can share information about my course and progress with my parents and recruiting agent; as deemed appropriate by the College.
12. I acknowledge the right of Mercedes College to change its fees and conditions, cancel or defer courses, and to alter course timetables and class locations at any time without notice. I acknowledge that professional counselling at the College is intended to ensure I am achieving their academic potential.

# Entry Requirements

Students who want to study at Mercedes College must have attained at least the equivalent level of study in their own country.

Students must successfully pass the subjects they wish to study at Mercedes College at their current school. Mercedes College is a school that welcomes students with a range of academic abilities who may achieve in other areas, such as sport or music. Students are encouraged to send any certificates from extra-curricular activities in which they participate. This will be considered in the enrolment process, in addition to academic achievements.

Students who have borderline results for English Language or do not produce evidence of their English language proficiency will be required to sit the Australian Education Assessment Services (AEAS) or IELTS test in their home country. Alternatively, students can do the EPET test at the Adelaide International School, and depending on the result students may be required to undertake five, 10, or 20 weeks of Intensive English at the South Australian College of English, or Adelaide International School in order to prepare them for their mainstream course. The time required is dependent on their level of English on entry to the College.

To qualify for the appropriate year level course of study, you must submit the past three years of the stated certificates/reports from your home country for assessment by senior staff at the College. Please refer to Table 1 for the equivalent school certificate.

Students must have scored a minimum of 80 per cent in the subjects that they wish to study at Mercedes College.

Academic performance: students wishing to find out whether they would be accepted should submit copies of their reports and/or official exam certificate for assessment.

1. For students who do not have demonstrated basic English proficiency, it is preferable that they sit the Australian Education Assessment Services (AEAS) test in their home country before they apply to Mercedes College. The Letter of Acceptance (LOA) can only be issued when we are provided with the results of the AEAS test or if students provide other evidence of English ability as outlined earlier in this form. This is an Australian Government Regulatory Authority requirement. Alternatively, students may be required to undertake five, 10, or 20 weeks of Intensive English at the South Australian College of English, or Adelaide International School, in order to prepare them for their mainstream course.
2. Assessment Level 1 and 2 countries need a letter from their English teacher and appropriate English grades for the selected course of study. Students from Assessment Level 3 and 4 countries are expected to meet the necessary English requirement by attending the Adelaide International School, or South Australian College of English, and also submitting a recent AEAS test.

## Completeness of Application

- Copies of academic reports for the last three years must accompany the Enrolment Application form.
- English Language proficiency must be proved by supplying any of the following documents or test scores TOEFL, IELTS, AEAS, or a recognised school certificate in English Proficiency. Applicants from Assessment Level 1 & 2 countries need a letter from their English teacher or current school Principal and appropriate English grades for the selected course of study, in addition to submitting a written essay on a form provided by Mercedes College.
- Once the enrolment has been approved, the application will be processed and a Letter of Acceptance will be sent. An additional, detailed document called the Written Agreement will also be forwarded to the student's family for the parents and students to sign and then forward to the school.
- Once these documents are received by the college, an electronic Confirmation of Enrolment document (eCoE) will be issued so that the Visa application process can be finalised. A copy of the original eCoE will be emailed to the Agent (or directly to the applicant if an Agent is not being used). A Confirmation of Appropriate Accommodation and Welfare (CAAW) document will be forwarded where relevant.
- The Written Agreement must be fully completed and signed by the parents and student and returned to the College. No student will be accepted into the college, regardless of payment, unless this signed document is returned to the Coordinator of International Enrolments.
- If payment is not made by the due date as outlined in the Letter of Acceptance, the Invoice and Written Agreement, the offered place may be withdrawn.

## Guardianship

Students enrolling under 14 years of age must have a family member, or guardian, accompany them while they live in Adelaide and study at Mercedes College. The College will not be responsible for the guardianship of the student until they reach Year 9 level of schooling. If a parent or suitable nominated relative takes responsibility for the welfare arrangements of the student, the college will not complete a Confirmation of Appropriate Accommodation and Welfare (CAAW) document.

The guardianship of a student cannot be changed from the Mercedes College Principal to another person unless the person is a proven blood relation over the age of 25, meets the conditions outlined by the Department of Home Affairs (Immigration) for a suitable guardian of a student under 18 years old, and only if the school receives written consent from the parents of the student.

## Payment

Mercedes College will provide tuition to the student in the subjects and for the enrolled course, provided payments of all fees are made by the due date of the issued invoices.

Enrolment, tuition, and other curriculum fees and overseas student health cover fees must be paid by the due date of the issued invoice.

## Adherence to Rules

The student undertakes to abide by the rules and regulations of Mercedes College and to work regularly and systematically through the course in accordance with instructions.

## Deferment and Suspension Conditions

Mercedes College will consider the deferment of a student's enrolment, before they commence at the college, if suitable evidence is submitted to Mercedes College showing sufficient reason for the deferment, for example, Visa delays, hospitalisation of the student, or other compassionate reasons.

The deferment procedure is that Mercedes College will hold the student's position at the College for the following year (for example, if the student defers entry at Year 9 and the reason has been accepted by the College, the student's Year 10 position is still confirmed for them in the following year). Deferment of the enrolment is at the discretion of the Principal.

## Suspension

Suspension can occur due to either disciplinary or compassionate reasons.

### Disciplinary Reasons

If a student has already commenced studies at Mercedes College, a suspension for disciplinary reasons will not exceed two weeks. There is no refund for fees for the suspended period.

### Compassionate Reasons

If a student has already commenced studies at Mercedes College, a suspension for compassionate reasons will not exceed two weeks. There is no refund for fees for the suspended period.

### Cancellation of Enrolment

If a student fails to attend 90 per cent of their course, or breaches school policies as outlined in the College Handbook, an intervention process by the school will occur. If the breach is proven to be serious enough and results in the non-compliance of the student's visa, the matter will be reported to the Department of Home Affairs (Immigration).

Mercedes College may also impose additional consequences for students found to have seriously breached school policy. Consequences could include the cancellation of an enrolment. Cancellation of an enrolment does not entitle the student to get a refund of their fees. See the Refund Policy (point three) and Additional Conditions of Enrolment (first dot point) in this International Student Enrolment form.

## Minimum Length of Stay

In accordance with the Commonwealth Department of Home Affairs (Immigration), students must remain with Mercedes College for the first six months of their principal course.

## Refund Policy

1. Students will receive a full refund of their tuition and course fees only if certified evidence from Australian Immigration authorities is provided within 14 days of the student receiving notice of a Visa application rejection.
2. Students will receive a refund of tuition and course fees

paid, less 20 per cent if, more than 28 days before the commencement of the course, a student provides written notification of cancellation or withdrawal from the course for any reason other than the rejection of the Visa application.

3. No refund is due if a student is required to leave the College due to a break in Visa conditions, including unsatisfactory attendance or unsatisfactory progress in the course, or a breach of College rules.
4. Other than the exceptions contained in points one to three, above, one semester's (around 15 academic weeks) notice in writing is required prior to students withdrawing from Mercedes College. Failure to provide notice in writing will incur a payment of one semester's tuition and course fees.
5. Refunds will be made in Australian Dollars only, to a nominated bank account in the name of the student.
6. Course fees are not transferable to other education providers.
7. The refund will be paid four weeks after notification by the student of withdrawal from the course.

## Variation of this Agreement

Any variation of the terms and conditions of this enrolment must be made in writing and signed by the Principal.

## Excursions and Medical Consent

If you fail or neglect to provide sufficient and current information in writing to enable the proper treatment of your child, no liability will be accepted by the school for any injury or illness which your child may suffer as a result.

## Additional Conditions of Enrolment

A place at Mercedes College is not assured until it is confirmed in writing by the college. Whilst all applications for enrolment are welcome, the student's enrolment cannot be confirmed until full consideration has been given to the individual needs of the applicant and whether the College can adequately meet those needs.

In confirming their acceptance of a place for their child at the College, parents/guardians:

- Agree to be bound by the rules and regulations of the College during their child's tenure AND agree that their child will be bound by those rules and regulations
- Authorise the College, in the event of their child's sickness or injury, to take such action as is necessary to obtain medical and/or hospital care and attention for their child and to pay all costs and expenses incurred on behalf of their child
- Agree to notify the Principal if they intend to cancel their child's enrolment prior to commencement, and they acknowledge the enrolment fee will be forfeited.

(Refer to Refund Policy in this Enrolment Form).

In addition to the above, parents/guardians are required to specify any special needs of their child which the college may need to consider in the delivery of their child's education.

## Privacy Policy

The following information is provided to families to assist in understanding the implications of the School's Privacy policy.

- Mercedes College respects the privacy of personal and sensitive information relating to your family. The College is committed to ensuring that it complies at all times with its requirements under the Commonwealth Privacy Act.
- The College collects personal information, including sensitive information about students and parents or guardians before and during the course of a student's enrolment at the College. The primary purpose of collecting this information is to enable the College to provide schooling to your child.
- It is the responsibility of the student, and their parents, to notify the College of any changes of address, or relevant personal details, while enrolled at Mercedes College. The College will regularly give the student an opportunity to update their information, for example when requesting the student to complete a form regarding their personal information. While this will occur regularly, it is not to be the only prompt to remind students to inform the College of changes in their address and circumstances.
- Some of the information we collect is to satisfy the College's legal obligations, particularly to enable the college to discharge its duty of care. Certain laws governing or relating to the operation of schools require from time to time, the disclosure of personal and sensitive information to relevant persons or authorities.
- Health information about students is sensitive information within the terms of the National Privacy Principles under the Privacy Act. We may ask you to provide medical reports about your child from time to time.
- The college from time to time discloses personal and sensitive information to others for administrative and educational purposes. This includes to other schools, government departments, the South Australian Commission for Catholic Schools, the Catholic Education Office, medical practitioners and people providing services to the school, including specialist visiting teachers, sports coaches and volunteers.
- Personal information about the student may be shared between Mercedes College and the Australian Government and designated authorities and, if relevant, the Tuition Protection Service (TPS) when the situation warrants the sharing of information. The request has to be put in writing by the Government, designated authority or TPS and considered by the Principal before permitting the information to be shared. The information can include personal and contact details, course enrolment details and changes, and the circumstances of any suspected breach by the student, of a Student Visa condition.
- In the event of default of payment of fees, the College may refer the default to a relevant organisation. If this occurs, personal information will be disclosed to the organisation and you will be responsible for the collection costs.
- If we do not obtain the information referred to above, we may not be able to continue the enrolment of your child.
- Personal information collected from students is regularly disclosed to their parents or guardians. On occasion information such as academic and sporting achievements, pupil activities and other news is published in the College newsletter, Fleur de Lis, the College Yearbook, and on our website.
- Parents, guardians or students may seek access to personal information collected about them by contacting the College. However, there will be occasions when such access is denied. Such occasions would include where access would have an unreasonable impact on the privacy of others, where access may result in a breach of the College's duty of care to the student, or where information has been provided in confidence.
- As you know the college from time to time engages in fundraising activities. Information received from you may be used to make an appeal to you. It may also be disclosed to organisations that assist in the College's fundraising activities solely for that purpose. We will not disclose your personal information to third parties for their own marketing or fundraising purposes without your consent.
- If you provide the College with personal information of others, such as doctors or emergency contacts, we encourage you to inform them that you are disclosing such information to the College and why, that they can access that information if they wish and that the College does not usually disclose the information to third parties.

If you would like further information about the way the College manages the personal information it holds, or if you wish to access personal information held by the college about yourself or your child, please contact the Principal in writing.
